As per provisions of the Rights of the Candidates with Disabilities Act, 2016, 4% reservation to Personal with Benchmark Disabilities (PWBD) has been provided as per instruction issued by the Government of India, Ministry of Personnel, Public Grievances & Pensions, Deptt. Of Personnel & Training vide O.M. No. 36035/02/2017-Estt. (Res) dated 15th January, 2018.
